The PDSAT is a key tool for ensuring data compliance in the further education/apprenticeship sectors. The PDSAT software is designed to analyse your ILR submission and provide reports on types of learners and possible data and funding issues.

It is also a large part of the Education and Skills Funding Agency's (ESFA) funding assurance approach, with significant time being spent on the analysis of these reports to determine if funds are at risk or data is incorrect.
