SUBCONTRACTING CONTROLS ASSURANCE

It has long been acknowledged that the Education and Skills Funding Agency (ESFA) has concerns in relation to subcontracted provision, with providers who are planning to subcontract provision for the first time needing to obtain ESFA permission.

As a result of a review of potential risks involved in subcontracting, the ESFA has a requirement for all providers which subcontract more than £100,000 of their provision within the year to obtain an annual report to provide assurance over the controls that they have in place in relation to subcontracted provision.
